DECISION ON PROSECUTION MOTION TO RE-OPEN ITS CASE-IN-CHIEF

On 23 October 2014, the Chamber granted the Prosecution's motion to reopen its case and present evidence in relation to the Tomašica mass grave. The Chamber concluded that the proposed evidence is "fresh" as well as relevant to the charges in the "municipalities" part of the case. The scheduling of the presentation of the new evidence (there should be 6 expert witnesses, 7 fact witnesses as well as documentary evidence for which the OTP asked 9 hours) will be determined at a later stage.
