On 30 January 2015, the Appeals Chamber rendered its judgement upholding the convictions against the accused: Popović and Beara were sentenced to life imprisonment, Drago Nikolić to 35 years' and Pandurević to 13 years' of imprisonment while Miletić's sentence was reduced to 18 years'—See Press Release number 1618, dated 30 January 2015.
