#### DEFENCE SUBMISSION AS TO PROPOSED MODALITY OF PROSECUTION RE-OPENING

On 11 March 2015, Mladic Defence filed a submission estimating it would need about three months to prepare for the Prosecution's reopening of its case. Specifically, it would need 10 weeks for investigation and 4 weeks of preparation. Subsequently, the Defence proposes the adjournment of this trial from 1 May until 16 August 2015, when the Prosecution would commence with the reopening. The Chamber will issue a decision on this issue in due course.
