# PUBLIC REDACTED VERSION OF THE 9 APRIL 2015 DECISION OF THE PRESIDENT ON THE EARLY RELEASE OF VINKO PANDUREVIĆ

On 10 April 2015, in a public redacted version of his decision, MICT President Meron granted early release to Vinko Pandurević, effective immediately.

#### DECISION ON URGENT INTERLOCUTORY APPEAL FROM DECISION DENYING PROVISIONAL RELEASE

On 13 April 2015, the Appeals Chamber granted the Defence appeal, quashed the decision of the Trial Chamber, filed on 13 March, and ordered the provisional release of Goran Hadžić as soon as practicable until a date kept confidential. During the release, Hadžić shall abide by a number of conditions, specified in the decision.

On 10 April 2015, the Trial Chamber in this case, before ruling on the merit of revocation of the accused's provisional release, ordered the Registry to present an updated report on the medical condition of Vojislav Šešelj.

#### ORDER REPLACING A JUDGE IN A CASE BEFORE THE APPEALS CHAMBER

On 14 April 2015, ICTY President Meron assigned Judge Delvoie to replace Judge Sekule on the appeals bench in charge of the issue of Šešelj's provisional release, namely the appeals bench that rendered the decision to revoke the provisional release, issued on 30 March.
