PUBLIC REDACTED VERSION OF THE 10 JULY 2015 DECISION OF THE PRESIDENT ON THE EARLY RELEASE OF NIKOLA ŠAINOVIĆ

On 27 August 2015, MICT President's order, filed confidentially on 10 July 2015, was made public granting early release to Nikola Šainović, effective 24 August or "as soon as practicable thereafter". The President concluded that Šainović had served two-thirds of his sentence and that he demonstrated signs of rehabilitation.
