##### **PUBLIC REDACTED VERSION OF THE 20 JULY 2015 DECISION OF THE PRESIDENT ON THE APPLICATION FOR EARLY RELEASE OR OTHER RELIEF OF DRAGO NIKOLIĆ**

On 13 October 2015, in a public redacted version of his order (filed confidentially on 20 July this year), MICT President Meron denied Drago Nikolic's request for early release but granted him provisional release from 24 July 2015 until 25 January 2016, subject to a number of conditions specified in the decision.
