HADŽIĆ case

PROSECUTION'S URGENT INTERLOCUTORY APPEAL FROM CONSOLIDATED DECISION ON THE CONTINUATION OF PROCEEDINGS

On 1 December 2015, the Prosecution in Hadžić case filed its appeal against the Chamber's decision to stay the proceedings in this case for the initial period of three months. The Prosecution requested the Appeals Chamber to, *inter alia*, reverse the impugned decision and order the Trial Chamber to resume with the Defence case.

ORDER ASSIGNING JUDGES TO A CASE BEFORE THE APPEALS CHAMBER

On 2 December 2015, ICTY President Agius assigned the Appeals Chamber for the Prosecution's appeal against the Trial Chamber's decision ordering a stay of proceedings in Hadžić case. The Appeals Chamber will be composed of Judges Agius, Daqun, Pocar, Meron and Afande.

ORDER LIFTING CONFIDENTIALITY OF ORDER IN LIEU OF INDICTMENT AND ARREST WARRANTS

On 1 December 2015, the Trial Chamber issued the public redacted versions of the order in lieu of indictment and the warrants of arrest against Petar Jojić, Jovo Ostojić and Vjerica Radeta. They are charged with contempt of the Tribunal for allegedly having threatened, intimidated, offered bribes to, or otherwise interfered with two witnesses in the trial against *Vojislav Šešelj* and a related contempt case against him – *See Press Release number 1642, dated 1 December 2015.*
