#### DECISION ON SECOND MOTION REGARDING A BREACH OF NON BIS IN IDEM

On 10 December 2015, Single Judge Liu dismissed the motion by Naser Orić's Defence to discontinue the current proceedings against him before the BiH Court. Judge Liu noted that the BiH charges are different

from the ICTY charges with respect to alleged victims, nature, time and location of his alleged criminal conduct and concluded that he is not "persuaded that the criminal proceedings instituted against Orić before the BiH Court are for acts constituting serious violations of international humanitarian law under the Statute, for which he has already been tried by the ICTY."
