### PROCEDURAL DEVELOPMENTS

#### I. OVERVIEW OF COURT PROCEEDINGS

##### MLADIĆ case

*Trial Chamber I – Judges Orić (Presiding), Moloto and Flüggé*

On 1 and 2 February 2016, the following witness testified:

- **Mile Matijević** (*Republika Srpska police official during the relevant period*)

##### JOJIĆ&OSTOJIĆ&RADETA case (“Contempt”)

##### Hearing

On 10 February 2016, the Chamber held a hearing to inquire with the Government of Serbia (whose representative was present) about its efforts to arrest the accused in the contempt case against Jojić, Ostojić and Radeta. The Chamber instructed Serbia to submit a report every two weeks describing in detail the actions it undertakes to arrest the three accused. The first such report is due on 24 February 2016.

On 22 January 2016, MICT Pre-trial Judge Hall scheduled a hearing in Stanišić&Simatović case for 19 February at 14:00 in courtroom 1. The hearing is scheduled pursuant to Rule 70 of the MICT Rules in order to establish a work plan for the parties.

**HADŽIĆ case***Appeals Chamber – Judges Agius (Presiding), Daqun, Pocar, Meron and Afande***ORDER IN RELATION TO PROSECUTION’S URGENT INTERLOCUTORY APPEAL FROM CONSOLIDATED DECISION ON THE CONTINUATION OF PROCEEDINGS**

On 25 January 2016, the Appeals Chamber extended the stay of trial proceedings in Goran Hadžić case until it has disposed of the Prosecution's appeal against the decision ordering a stay of the proceedings for the initial period of 3 months (due to the medical condition of the accused).

**TOLIMIR case***MICT President Meron***ORDER ASSIGNING A JUDGE TO CONDUCT AN INQUIRY**

On 9 February 2016, the Mechanism President Meron, being informed that Zdravko Tolimir passed away on 8 February in the UN Detention Unit, assigned Judge Joensen to conduct an inquiry into the circumstances surrounding the death of Tolimir and report the findings as soon as is reasonably possible.
