PUBLIC REDACTED VERSION OF 24 MARCH 2016 DECISION ON REMAND ON THE CONTINUATION OF PROCEEDINGS

On 5 April 2016, in the public redacted version of its decision (filed confidentially on 24 March), the Trial Chamber declared Goran Hadžić currently unfit to stand trial and stayed the present proceedings indefinitely.

DECISION ON REQUEST FOR RECONSIDERATION OF DECISION CONTINUING PROHIBITION OF SOCIAL CONTACTS DURING PROVISIONAL RELEASE

On 19 April 2016, the Trial Chamber granted the Defence motion and ordered the modification of the provisional release conditions in order to allow Hadžić to have social contact with six Defence witnesses.

The Chamber concluded that, given its latest decision ordering the indefinite stay of the proceedings, prohibiting the accused's social contact with the witnesses is not necessary "in order to safeguard the integrity of the proceedings and the administration of justice".
