DECISION ON APPELLANT MOMČILO KRAJIŠNIK'S MOTION TO CALL RADOVAN KARADŽIĆ PURSUANT TO RULE 115

On 16 October 2008, the Appeals Chamber granted a motion by Momčilo Krajišnik to call Radovan Karadžić as a witness pursuant to Rule 115 and ordered that the evidentiary hearing shall be held on 3 November and 5 November 2008. The Chamber also granted counsel's request to interview Karadžić and to question him on issues relating to the Joint Criminal Enterprise. The Registry is directed to provide the arrangements necessary for the appellant to have further meetings with the witness in order to determine the precise scope of his evidence. A scheduling order for the hearing will be issued in due course.
