On 26 November 2008, Trial Chamber III determined that the Defence of Sredoje Lukić may call four witnesses and that the time for examination-in-chief of these witnesses shall be two hours, whereas the Defence of Milan Lukić may call 45 witnesses and the time for their examination-in-chief shall be 60 hours, so that the Defence will conclude the presentation of its evidence no later than Friday, 6 March 2009.
