KUPRESKIC & OTHERS CASE: TENTATIVE TRIAL DATE SET FOR 17 AUGUST 1998

A closed Status Conference was held on 15 May 1998 in the above case, during which the Trial Chamber set for MONDAY 17 AUGUST 1998, at 9.30 am, the tentative trial commencement date. It also ordered the parties to file their pre-trial briefs by Monday 13 July 1998 for the Prosecution and by Friday 31 July 1998 for the Defence.
