BLASKIC CASE:

DEFENCE "MOTION TO DISMISS" DENIED

On Thursday 3 September 1998, Trial Chamber I, consisting of Judge Jorda, presiding, Judge Riad and Judge Shahabuddeen, unanimoulsy denied the Defence Motion to dismiss "several allegations pertaining to the accused's direct or command responsibility for the crimes purportedly committed by his subordinates [which] are unsupported and must be stricken from the indictment".

The Trial Chamber considered that no count can be stricken in full or in part "at this stage of the trial".

DEFENCE TO BEGINS ITS CASE ON MONDAY 7 SEPTEMBER

CELEBICI CASE:

PROSECUTOR'S APPLICATION FOR LEAVE TO APPEAL DENIED

On 29 August 1998, on the eve of the final trial week, a Bench of three Judges of the Appeals Chamber (Judge Vohrah, presiding, Judge Tieya and Judge Nieto-Navia) unanimously refused to grant the Prosecutor leave to appeal against the Trial Chamber's Decision of 19 August not to re-open the Prosecution case.

The Bench of Appeals Chambre's Judges found that "neither the order to grant the Prosecution leave to call only one witness in rebuttal of the defence case nor the Decision to reject the Prosecution's alternative request to re-open its case would cause such prejudice to the case of the Prosecution as could not be cured by the final disposal of the trial including post-judgement appeal (...)'.
