WEEKLY PRESS BRIEFINGS TO RESUME

2 October 1998

A press briefing will be given on TUESDAY 6 OCTOBER 1998 at 1.30 P.M. to outline practical and personal changes affecting the press operations at the ICTY.

Mr. Christian Chartier will introduce a newly appointed Spokesperson, Mr. Jim Landale, who will be in charge of all ICTY matters, with the exception of those relating to the Office of the Prosecutor.

A representative of the Office of the Prosecutor will participate in the briefing. This briefing marks the resumption of regular weekly press briefings.

FURUNDZIJA CASE:

On Thursday 1 October 1998, Trial Chamber II (consisting of Judge Mumba, presiding, Judge Cassese and Judge May) decided that the re-opening of the oral proceedings in *The Prosecutor v. Anto Furundzija* case would commence on MONDAY 9 NOVEMBER at 9.30 a.m.

KUPRESKIC & OTHERS CASE:

On Wednesday 30 September 1998, Trial Chamber II (consisting of Judge Cassese, presiding, Judge May and Judge Mumba) issued a Witness Summons. The witness, identified in court papers as Witness SA, is a Prosecution witness who was listed to testify on 4 September, but was unable to do so due to infirmity, and who was then withdrawn by the Prosecutor. However, using its powers under Rule 98 of the Rules of Procedure and Evidence ("A Trial Chamber...may propriu motu summon witnesses and order their attendance"), the Trial Chamber has decided to summon this witness and has requested the Victims and Witnesses Unit "to manage all the practical aspects related to bringing the witness to the Tribunal to testify (...)".

Witness SA will appear in the week commencing 5 October 1998.
