LAST MINUTE NEWS

CELEBICI CASE:

COMPOSITION OF THE APPEALS CHAMBER:

On 20 January 1999, the Vice-President of the Tribunal, exercising the functions of the President in her absence, assigned the following Judges to the Appeals Chamber in the Celebici case: Judge Mohamed Shahabuddeen, Judge Wang Tieya, Judge Rafael Nieto-Navia, Judge David Hunt and Judge Mohamed Bennouna.

COUNSEL FOR DELIC REQUESTS ADDITIONAL TIME FOR FILING APPELLATE BRIEF:

Hazim Delic's counsel filed on 15 January a motion for an extension of time to file his appellate brief. Delic's lawyers requested that "*his deadline for filing his appellate brief be extended until the date set for Mucic*". One recalls that Mucic filed on 28 December a request for the time of filing appellate documents to be extended to 31 August 1999 (See Update nr. 60). The Appeals Chamber has not ruled yet.

MOTIONS FOR PROVISIONAL RELEASE:

Simo Zaric and Miroslav Tadic, have filed motions requesting their provisional release. Both motions were filed on 18 January 1999.

The Defence Counsel for Mladjo Radic filed on 14 January a preliminary motion "*challenging the jurisdiction of the Tribunal and pointing to the defects in the form of the indictment*".
