## LAST MINUTE NEWS

### “SIMIC & OTHERS” (Bosanski Samac) CASE:

#### **MIROSLAV TADIC SEEKS LEAVE TO APPEAL**

On 3 March 1999, the Defence for Miroslav Tadic filed an Application for leave to appeal against the Decision by Trial Chamber III on 15 February 1999 to dismiss the motion for provisional release (see Update No. 66).

### KRSTIC CASE:

#### **DEFENCE MOTION ON THE FORM OF THE INDICTMENT**

On 1 March 1999, the Defence for General Krstic filed a *Motion on the form of the indictment* in which “defects in the form of the indictment” are pointed out. The indictment is said to be “vague, undefined, contradictory and ungrounded”

#### **DECISIONS ON DEFENCE MOTIONS**

On 1 and 2 March 1999, Trial Chamber III, consisting of Judge May, presiding, Judge Bennouna and Judge Robinson, disposed of the Joint Motions filed on 22 January 1999 by the Defence Counsels for the two accused (see Update No. 63). The nine Motions were all dismissed.
