FURUNDZIJA CASE:

THE BUREAU DISMISSES THE DEFENCE POST-TRIAL APPLICATION AND MOTIONS

On Thursday 11 March 1999, the Bureau of the ICTY issued its Decision on the *Post-trial application by Anto Furundzija to the Bureau of the Tribunal for the disqualification of Presiding Judge Mumba, Motion to Vacate Conviction and Sentence, and Motion for a New Trial* (see Update No. 64).

The Bureau (consisting of Judge McDonald, Judge Jorda, Judge Rodrigues, Judge Hunt and Judge Bennouna): "...without considering the merits of the Application or of the Motions, dismisses them upon the basis that they do not fall within the competence of the Bureau".

ALEKSOVSKI CASE:

TRIAL NEARS COMPLETION

Further to a Scheduling Order by Trial Chamber I (presided over by Judge Rodrigues) of 5 March 1999, the closing arguments of the Prosecution and the Defense are to be presented in court on Monday 22 and Tuesday 23 March 1999 respectively from 2 p.m. to 6 p.m..
