KUPREŠKIĆ & OTHERS CASE

SCHEDULING ORDER ISSUED

Trial Chamber II (Judges Cassese (Presiding), May and Mumba) will render its Judgement in the Kupreškić & others case on **Friday 14 January 2000** at **9.00** am.

PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS

The Trial Chambers are now in recess. Hearings will resume on Monday 10 January 2000.

JELISIĆ CASE

Trial Chamber I – Judges Jorda (Presiding), Riad and Rodrigues

On Tuesday, the Trial Chamber issued its written Judgement on all counts charged in the indictment. Acquitting Jelisić of the one count of genocide to which he pleaded "not guilty" on 29 October 1998, the Trial Chamber sentenced Jelisić to 40 years' imprisonment for the 31 counts of violations of the law or customs of war and crimes against humanity to which he pleaded "guilty" (see Press Release No. 454).

KUNARAC & KOVAČ CASE

Trial Chamber II – Judges Mumba (Presiding), Cassese and Hunt

A status conference was held in open session on Tuesday during which it was decided that the start of the trial will be postponed until **20 March 2000** to allow counsel for Kovač to prepare his defence.
