LATEST NEWS:

Paško LJUBIČIĆ Case

Trial Chamber I - Judges Liu (Presiding), Elmahdi and Orie

The initial appearance for Paško Ljubičić was held this Friday, 30 November 2001 at 14:00 in Courtroom I. He pleaded not guilty to all counts.

PROCEDURAL DEVELOPMENTS:

OVERVIEW OF COURT PROCEEDINGS:

Mladen NALETILIĆ and Vinko MARTINOVIĆ Case ("Tuta" and "Štela")

Trial Chamber I – Judges Liu (Presiding), Harding Clark and Diarra

On 26 November 2001, protected witness QQ was cross-examined by the Defence. QQ told the court about the various Croatian forces that he saw in the Heliodrom.

In the afternoon of 27 November the Prosecution heard protected witness RR via video link. After the Prosecution's examination, RR was cross-examined by the Defence.

The following day, SS testified about the encounters that he had with Mladen Naletilić.

On 29 November, the court heard protected witness TT also via video link. The Prosecutor asked TT about events taking place in Sovići and Ljubuški in 1993. He also told the court that he saw Mladen Naletilić at the Heliodrom where the witness was detained. The witness also testified about his detention at a prison in Ljubuški.

On Friday, protected witness SS resumed his testimony that he had started on Wednesday.

Mitar VASILJEVIĆ Case ("Višegrad")

Trial Chamber II – Judges Hunt (Presiding), Janů and Taya

On 26 November 2001, the Prosecution cross-examined Radomir Vasiljević. After the morning break, the Defence called witness Milena Tomašević, the head nurse of the psychiatric ward of the general hospital in Užice. She had worked in this ward from 1979 onwards. The accused stayed in this ward for a period of time in 1992.

On 27 November, witness Slobodan Simić who was a doctor at the Užice hospital talked about the medical condition of the accused. In the afternoon the Defence called Slavica Pavlović, an employee at the Užice hospital at the time the accused was there.

The next day, the Defence resumed its examination of Pavlović. In the afternoon she was crossexamined by the Prosecution.

On Thursday the Defence called witness Borisav Martinović, a psychiatrist who discussed the medical situation of the accused in 1992. In the latter part of the morning, the Defence called witness Slavica Jevtović, a neuro-psychiatrist who has been working in the general hospital in Užice since June 1966. She worked in the psychiatric ward in 1992 when Mitar Vasiljević was hospitalized there.

On 30 November, Defence witness Snežana Nešković, a lawyer, testified about the ethnic composition of the municipal assembly and the executive council in Višegrad. She also testified about Serbs who fled to Serbia and to surrounding Serb villages. After this witness the Defence continued the examination of Ivan Jovanović which had started the day before.

Trial Chamber II, Section B – Judges Mumba (Presiding), Singh and Williams

On Monday morning, 26 November 2001, the Defence cross-examined protected witness L. He was questioned about his exchange and transfer to Batković in 1993.

On the following day, the court heard protected witness K mostly in closed session.

On 28 November the Trial Chamber heard the testimony of another witness in closed session.

The following day K was cross-examined by the Defence.

On 30 November witness K resumed his testimony before the court.

On 29 November, the Trial Chamber convened for a status conference during which the progress of the pre-trial preparation was discussed.

DECISION ON FORM OF FOURTH AMENDED INDICTMENT

On 23 November 2001, the Trial Chamber:

- (1) rejected the complaint by Momir Talić that the case pleaded in para. 20.1 was defective.
- rejected the complaint by Momit Talić that the form of the Indictment was defective because it did not identify the leaders of the Bosnian Serbs who formed the ARK Crisis Staff.
- refused the Prosecution's leave to amend para. 40 of the previous Indictment and struck the amendment made to para. 40 of the current Indictment.
- (4) granted the Prosecution leave to amend paras. 5 and 6 of the Request.
- (5) refused the Prosecution leave to amend para. 8 of the Request; and struck the amendments to the current Indictment.

Slobodan MILOŠEVIĆ Case ("Kosovo"), ("Croatia") and ("Bosnia and Herzegovina")

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

SCHEDULING ORDER

On 23 November 2001, the Trial Chamber ordered the Prosecution to file any application for joinder of the three Milošević cases (on Kosovo, Croatia and Bosnia and Herzegovina) by close of business on 27 November 2001. The *amici curiae* shall then have until 12:00 on 10 December to file their responses, if any. The Trial Chamber will hear oral arguments on the Motion for joinder on **11 December 2001.** The initial appearance of Slobodan Milošević for the Bosnia and Herzegovina Indictment was scheduled to take place on the same day at **9:30.**

LATEST DEVELOPMENT

On 27 November 2001, the Prosecution filed a motion to join the three Milošević cases.

ORDER INVITING DESIGNATION OF AMICUS CURIAE

- On 23 November, the Trial Chamber invited the Registrar to designate three *amici curiae*, to assist the Trial Chamber by:
- (1) making any submissions properly open to the accused by way of preliminary or other pre-trial motion:
- (2) making any submissions or objections to evidence properly open to the accused during the trial proceedings and cross-examining witness as appropriate;
- (3) drawing to the attention of the Trial Chamber any exculpatory or mitigating evidence; and

acting in any other way which designated counsel considers appropriate in order to secure a fair trial.
