The Trial Chamber convened to hear the Defence case for Naletilić and Martinović.

MILOŠEVIĆ Case (“Croatia and Bosnia and Herzegovina”)

On 26 and 27 September 2002, the Trial Chamber convened to hear the first week of the Prosecution case regarding Croatia and Bosnia and Herzegovina. The Prosecution and the Accused made their opening statements. On 27 September, the Prosecution examined the following witness:

LJUBIČIĆ Case

Trial Chamber I – Pre-Trial Judge El Mahdi

On 26 September 2002, the Trial Chamber convened for the second initial appearance of the Accused which was followed by a Status Conference. The Accused pleaded "not guilty" to all counts on the Indictment.

MARTIĆ Case ("Zagreb Bombing")

Trial Chamber I – Judges Liu (Presiding), El Mahdi and Orić

On 23 September 2002, the Trial Chamber convened for a hearing on the Defence Motion for Provisional Release. Representatives of the Federal Republic of Yugoslavia participated in the hearing. Following this hearing, a Status Conference took place.

MACEDONIA Deferral Case

Trial Chamber I – Judges Liu (Presiding), El Mahdi and Orić

On 25 September 2002, the Trial Chamber convened for a hearing on the Prosecution Request for Deferral. The Public Prosecutor General of the Former Yugoslav Republic of Macedonia participated in the hearing. The Trial Chamber will render its Decision in due course.
