DECISION ON DEFENCE REQUEST FOR PERMISSION TO ATTEND FUNERAL

On 2 December 2002, the Trial Chamber dismissed the Defence Request filed on 2 December in which Paško Ljubičić requested permission to attend his brother’s funeral on that same day.

On 29 November 2002, the Appeals Chamber rendered its Decision rejecting a challenge by the Republic of Croatia to the Decision and Orders of Confirming Judge (see *Press Release* No. 714). President Jorda and Judge Shahabuddeen appended a Declaration, and Judges Hunt and Pocar appended a Separate Opinion.

DECISION ON THE APPEAL OF THE DEFENCE AGAINST REGISTRY DECISION DATED 25 SEPTEMBER 2002

On 3 December 2002, the Trial Chamber rejected Martić’s Appeal against the Registry Decision of 25 September 2002 according to which 50 hours of investigative work at the pre-trial stage shall be borne by the Accused.
