DECISION ON MOMČILO GRUBAN’S MOTION FOR ACCESS TO MATERIAL

On 13 January 2002, the Appeals Chamber granted Momčilo Gruban’s Motion of 6 June 2002 and ordered, *inter alia*, that the Prosecution and the Defence in Kvočka *et al.* seek the consent of the providers of the material before disclosing to Gruban the non-public material which falls under Rule 70 (C) of the Rules of Procedure and Evidence.

BLAGOJEVIĆ *et al.* Case (“Srebrenica”)

DECISION ON APPLICATIONS BY BLAGOJEVIĆ AND OBRENOVIĆ FOR LEAVE TO APPEAL

On 16 January 2002, a Bench of the Appeals Chamber granted Vidoje Blagojević leave to appeal and refused Dragan Obrenović’s request for leave to appeal against the Decision of Trial Chamber II. Trial Chamber II refused to grant either Blagojević or Obrenović provisional release in separate decisions of 19 November 2002.
