ŠEŠELJ Case

On 26 February 2003, following his transfer to the Tribunal on 24 February (see *Press Release* No. 732), Vojislav Šešelj appeared before Judge Schomburg for his initial appearance. The Accused did not enter a plea immediately but will make a further initial appearance within 30 days.

On 26 February 2003, the parties appeared before the Pre-Trial Judge for a Status Conference pursuant to Rule 65 *bis* of the Rules of Procedure and Evidence.

BLAŠKIĆ Case ("Lašva Valley")

On 26 February 2003, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence. Counsel for Tihomir Blaškić were not present in the Courtroom but participated via telephone link.

PLAVŠIĆ Case ("Bosnia and Herzegovina")

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

On 27 February 2003, the Trial Chamber rendered its Sentencing Judgement in the Plavšić case. Biljana Plavšić was sentenced to 11 years' imprisonment for one count of persecutions on political, racial and religious grounds, a crime against humanity to which she pleaded guilty on 2 October 2002 (See *Press Release* No. 734).

LIMAJ et al. Case

Pre-Trial Judge Liu

On 28 February 2003, the parties appeared before the Pre-Trial Judge for a hearing regarding the Accused Agim Murtezi. The Judge withdrew the Indictment against Agim Murtezi and ordered his immediate release (see *Press Release* No. 736).
