DECISION ON APPEAL FROM REFUSAL OF APPLICATION FOR DISQUALIFICATION AND WITHDRAWAL OF JUDGE

On 13 March 2003, the Appeals Chamber referred the original application of the Galić Defence to withdraw Judge Orie from the case to the Bureau. The Defence filed this Request for Withdrawal of Judge Alphons Orie on 23 January 2003. Judge Liu, as President of Trial Chamber I, rendered a Decision on the Defence Motion on 3 February 2003 (see *Weekly Update* No. 253) and the Defence filed their Request for Certification to Appeal Against Judge Liu Daqun's Decision on 10 February 2003.
