## I. <u>OVERVIEW OF COURT PROCEEDINGS:</u>

## MILOŠEVIĆ Case ("Croatia and Bosnia and Herzegovina")

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

38<sup>th</sup> week of the Prosecution case.

Due to the illness of the scheduled witness, the hearing of 27 August 2003 was cancelled. On 28 August and 29 August 2003, the hearings took place mainly in closed session.

## RAŠEVIĆ Case ("Foča")

Duty Judge Pocar

Following his transfer to the Tribunal on 15 August 2003 (see *Press Release* No. 775), Mitar Rašević appeared before Judge Pocar for his initial appearance. He did not enter a plea at this date. A date for a further initial appearance will be scheduled within 30 days.

## STRUGAR and JOKIĆ Case ("Dubrovnik")

Trial Chamber I – Judges Orie (Presiding), El Mahdi and Martín Canivell

On 27 August 2003, the parties appeared before the Trial Chamber for a hearing on a joint motion for the consideration of Plea Agreement between Miodrag Jokić and the Office of the Prosecutor. Miodrag Jokić pleaded guilty to the six counts of violations of the laws or customs of war of the Second Amended Indictment (see *Press Release* No. 776).

## NALETILIĆ and MARTINOVIĆ Case ("Tuta and Štela")

Pre-Appeal Judge Pocar

On 29 August 2003, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence.

#### SCHEDULING ORDER

On 1 August 2003, the Trial Chamber ordered that the Prosecutor and the Defense file their sentencing briefs and statements of witnesses on whom they intend to rely by 8 September 2003 and that the Sentencing Hearing be held on Monday 22 September 2003 at 9 a.m.

On 28 August 2003, the Defence filed a motion to request that the deadline for the filing of Sentencing Briefs and witness statements be extended to 8 October 2003 and that the sentencing hearing take place on 22 October 2003. The motion is under consideration before the Trial Chamber.

#### ORDER OF THE PRESIDENT IN RESPONSE TO MIROSLAV KVOČKA'S REQUEST FOR PARDON

On 7 August 2003, the President of the Tribunal dismissed Miroslav Kvočka's Request for Granting of Pardon filed on 31 July 2003. The President noted that a petition for provisional release should be filed before the Appeals Chamber.

#### DECISION ON PROSECUTION'S MOTION FOR EXTENSION OF TIME

On 19 August 2003, the Duty Judge granted the Prosecution 15 August 2003 Motion for extension of time and ordered *inter alia* that the Trial commence on 9 October 2003.

### DECISION ON ASSIGNMENT OF DEFENCE COUNSEL

On 20 August 2003, the President of the Tribunal quashed the Registrar's Decision of 9 July 2003 refusing to assign Veselin Šljivančanin's Defence counsel of his own choice. The President remanded the matter back to the Registrar for reconsideration in light of this Decision.
