PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

The overview of the Milosević and of the Blagojević & Jokić cases will be published in the next issue of the Weekly Update.

RAŠEVIĆ Case ("Foča")

Judge Janu

On 16 September 2003, following his transfer to the Tribunal on 15 August 2003 and Initial Appearance on 18 August 2003, the parties appeared before Judge Janu for Mitar Rašević's Further Initial Appearance. The Accused declined again to enter a plea. Judge Janu therefore entered a plea of "not guilty" on his behalf, pursuant to Rule 62(iv) of the Rules of Procedure and Evidence: the Judge shall "if the accused fails to enter a plea at the initial or any further appearance, enter a plea of not guilty on the accused's behalf".

KRNOJELAC Case ("Foča")

Appeals Chamber - Judges Jorda (Presiding), Schomburg, Shahabuddeen, Güney and Agius

On 17 September 2003, the parties appeared before the Appeals Chamber for the pronouncement of the Appeals Judgement. The Appeals Chamber expanded the criminal responsibility and the culpability of the Accused, quashed the acquittal pronounced by the Trial Chamber on two counts of crimes against humanity (torture and murders) and on two counts of violations of the laws or customs of war (torture and murders) and declared the Accused guilty of them. It revised the sentence and raised it to 15 years' imprisonment (see *Press Release* No. 783).
