PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

MILOŠEVIĆ Case ("Croatia and Bosnia and Herzegovina")

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

42nd week of the Prosecution case.

From 7 until 9 October 2003, the following witnesses were examined by the Prosecution and subsequently cross-examined by the Accused and one of the *amici curiae*:

- Expert Witness Ewa Tabeau
- Witness Milan Milanović (has not yet been cross-examined)
- Witness General Sir Rupert Smith

BLAGOJEVIĆ and JOKIĆ Case ("Srebrenica")

Trial Chamber I, Section A – Judges Liu (Presiding), Vassylenko and Argibay

9th week of the Prosecution case.

From 6 until 10 October 2003, the Prosecution continued the examination of Dragan Obrenović and the Defence subsequently cross-examined him.

ČEŠIĆ Case ("Brčko")

Trial Chamber I - Judges Orie (Presiding), Liu and El Mahdi

On 8 October 2003, the parties appeared before the Trial Chamber for a hearing on the Joint Motion for Consideration of the Plea Agreement between Ranko Češić and the Prosecutor. The Prosecution suggested a sentence of 13 to 18 years' imprisonment. The Accused pleaded guilty to all 12 counts of the Indictment. The Trial Chamber accepted the guilty plea of the Accused and found him guilty on each count of the Indictment. A date for the sentencing hearing will be scheduled in due course (see *Press Release* No. 787).

BRĐANIN Case ("Krajina")

Trial Chamber II Section A – Judges Agius (Presiding), Janu and Taya

On 9 October 2003, the parties appeared before the Trial Chamber for a Pre-Defence Hearing pursuant to Rule 73 ter of the Rules of Procedure and Evidence. Before the Pre-Defence Hearing started, the Trial Chamber gave an oral Ruling on the Defence Motion for Judgement of Acquittal pursuant to Rule 98 bis filed confidentially on 22 August 2003. The Trial Chamber granted the Defence Motion in part and ruled that there was no case to answer regarding certain elements and incidents in the Indictment. The written Decision will be filed at a subsequent date.

DERONJIĆ Case ("Glogova")

Trial Chamber II - Judges Schomburg (Presiding), Mumba and Agius

SCHEDULING ORDER

On 3 October 2003, the Trial Chamber ordered *inter alia* that the Registrar appoint an expert to submit a report on the Accused's socialisation and that the sentencing hearing be held from 27 to 30 January 2004.

DECISION ON THE DEFENCE "OBJECTION TO INTERCEPT EVIDENCE"

On 3 October 2003, the Trial Chamber rejected the Objection and Supplemental Objection filed by the Defence on 3 July and 18 July 2003 respectively, objecting to the admission of evidence obtained through the allegedly illegal interception of telephone conversations.

ORDER OF FURTHER INSTRUCTION TO THE AMICI CURIAE

On 6 October 2003, the Trial Chamber extended the role of the *amici curiae* having regard to the recurring medical condition of the Accused since 18 March 2002 and to the desirability of the *amici curiae* giving greater assistance to the Accused. It authorized them to receive such communications as the Accused may make to them and to act in any way to protect and further the interests of his Defence.

ORDER TO THE RIGHT HONORABLE THE LORD OWEN TO TESTIFY AND TO PROVIDE WRITTEN STATEMENT PRIOR TO TESTIFYING

On 4 September 2003, the Trial Chamber ordered Lord David Owen to testify on 3 and 4 November 2003 and invited him to submit a concise written statement covering matters set out in the Order which include *inter alia* his appointment and mandate in the former Yugoslavia, his meetings with the Accused and the leaders of the Federal republic of Yugoslavia and the Croatian and Bosnian Serbs, and his observations of the relations between the Accused and those leaders. The Order was filed confidentially and made public this week.

Momir NIKOLIĆ Case ("Srebrenica")

Trial Chamber I, Section A – Judges Liu (Presiding), Vassylenko and Argibay
