PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

KRSTIĆ Case (“Srebrenica”)

Appeal Chamber – Judges Meron (Presiding), Pocar, Shahabuddeen, Güney and Schomburg

JUDGEMENT

On 19 April 2004, the parties appeared before the Appeals Chamber for the pronouncement of the Appeals Judgement in the Krstić case. The Appeals Chamber *inter alia* set aside, Judge Shahabuddeen dissenting, Radislav Krstić’s conviction as a participant in a joint criminal enterprise to commit genocide and found, Judge Shahabuddeen dissenting, Radislav Krstić guilty of aiding and abetting genocide. The Appeals Chamber unanimously reduced Radislav Krstić’s sentence from 46 to 35 years’ imprisonment (see *Press Release* No. 839). Judge Shahabuddeen appended a Partial Dissenting Opinion.
