PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

HADŽIHASANOVIĆ and KUBURA Case ("Central Bosnia")

Trial Chamber II - Judges Antonetti (Presiding), Rasoazanany and Swart

BABIĆ Case

Trial Chamber I - Judges Orie (Presiding), El Mahdi and Martín Canivell

On 29 June 2004, the Trial Chamber convened for the pronouncement of the Sentencing Judgement in the Milan Babić case. The Trial Chamber sentenced Milan Babić to 13 years' imprisonment (see *Press Release* No. 861). On 27 January 2004, Milan Babić had pleaded guilty to Count 1 of the Indictment, namely persecutions on political, racial, and religious grounds (see *Press Releases* No. 818 and No. 819). The Prosecution had recommended a sentence of no more than 11 years and the Defence had made no specific recommendation.

BLAGOJEVIĆ and JOKIĆ Case ("Srebrenica")

Trial Chamber I, Section A – Judges Liu (Presiding), Vassylenko and Argibay

First week of the Dragan Jokić Defence case.

On 1 July 2004, the Defence for Dragan Jokić made its opening statement pursuant to Rule 84 of the Rules of Procedure and Evidence.

SCHEDULING ORDER FOR AN INITIAL APPEARANCE, AND REQUEST FOR THE DETENTION OF MIRKO NORAC AND HIS SURRENDER TO THE NETHERLANDS

On 30 June 2004, the Trial Chamber scheduled a hearing for Mirko Norac to enter a plea to the charges raised against him before this Tribunal. The Trial Chamber requested the Government of Croatia to detain the Accused and the Government of the Kingdom of the Netherlands to detain the Accused and to transport him from Schiphol Airport to the United Nations Detention Unit (see *Press Release* No. 866).

DECISION ON THE PROSECUTOR'S MOTION TO OPPOSE THE INITIAL APPEARANCE OF MIRKO NORAC

On 30 June 2004, the Trial Chamber found that the Accused had to be called to enter a plea to the charges raised against him in the Indictment and dismissed the Prosecutor's 24 June 2004 Motion against Mirko Norac's Initial Appearance.
