### ORDER ON PROSECUTOR'S MOTION TO STAY ORDERS ON PROVISIONAL RELEASE

On 4 August 2004, the Duty Judge remitted the Prosecution's application for a stay of the Orders on Provisional Release concerning the six co-Accused to Trial Chamber I for determination. The Duty Judge ordered that the six Accused are to remain in the custody of the Tribunal pending resolution of the Prosecution's Application by Trial Chamber I (see *Press Release* No. 881).

### Trial Chamber I – Judges Liu (Presiding), El Mahdi and Orie DECISION ON PROSECUTION'S MOTION FOR STAY OF ORDERS ON PROVISIONAL RELEASE OF ACCUSED

On 9 August 2004, the Trial Chamber rejected the Prosecution Motion to stay the provisional release filed before the Duty Judge on 3 August 2004. The Prosecution filed an application for leave to appeal the Decision.

### Appeals Chamber – Judges Meron (Presiding), Pocar and Güney ORDER ON PROSECUTION'S MOTION FOR A STAY

On 10 August 2004, a Bench of three Appeals Chamber's Judges stayed the Orders previously issued by Trial Chamber I on the provisional release of Jadranko Prlić, Bruno Stojić, Slobodan Praljak, Milivoj Petković, Valentin Ćorić and Berislav Pušić (see *Press Release* No. 883).

# DECISION ON EXTENSION OF TIME FOR FILING AMENDED VERSION OF MODIFIED CONSOLIDATED AMENDED INDICTMENT

On 6 August 2004, Trial Chamber III ordered the Accused and the *Amici Curiae* to file submissions in response to the confidential "Prosecution's Submissions In Response to the Trial Chamber's 19 July 2004 'Further Order On Future Conduct of the Trial' filed on 26 July 2004 (see *Press Releases* 871 and 882).

### Trial Chamber III - Judges Robinson (Presiding), Kwon and Bonomy

SCHEDULING ORDER CONCERNING RECOMMENCEMENT OF THE TRIAL

On 25 August 2004, Trial Chamber III ordered that:

- (1) The trial will recommence on 31 August 2004, the trial schedule being as follows:
  - (a) the Accused will make his opening statement;
  - (b) following the opening statement of the Accused, there will be a procedural hearing at which the parties and *Amici Curiae* may make further submissions concerning the content of the medical reports and assignment of defence counsel, and raise, with leave of the Trial Chamber, any other urgent procedural issues;
  - (c) the Trial Chamber will thereafter issue a further order concerning these matters; and
  - (d) no evidence will be heard until Tuesday, 7 September 2004; and
- (2) Whilst severance of one or more of the indictments remains an option, the Trial Chamber will not give further consideration to it at this time (see *Press Release* No. 886).
