PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

KRAJIŠNIK Case (“Bosnia and Herzegovina”)

Trial Chamber I - Judges Orić (Presiding), El Mahdi and Martín Canivell

21th week of the Prosecution case.

HADŽIHASANOVIĆ and KUBURA Case (“Central Bosnia”)

Trial Chamber II - Judges Antonetti (Presiding), Rasoazanany and Swart

Fourth week of the Hadžihasanović Defence case.

Beqa BEQAJ Case (“Contempt of the Tribunal”)

Trial Chamber I – Judges Liu (Presiding), El Mahdi and Orić

Following his transfer to the Tribunal on 5 November 2004, Beqa Beqaj pleaded not guilty to the three counts of the Indictment. The Prosecution filed an Amended Indictment with the correct spelling of the Accused name on the same day.

MILOŠEVIĆ Case (“Kosovo, Croatia and Bosnia and Herzegovina”)

Trial Chamber III - Judges Robinson (Presiding), Kwon and Bonomy

Sixth week of the Defence case.

From 9 until 11 November 2004, the parties discussed the withdrawal request of the Court assigned Defence counsel.

STANKOVIĆ Case (“Foča”)

Pre-Trial Judge El Mahdi

On 9 November 2004, the parties appeared before the Pre-Trial Judge for a Status Conference pursuant to Rule 65 *bis* of the Rules of Procedure and Evidence.

BEARA Case (“Srebrenica”)

Judge Bonomy

On 9 November 2004, following his initial appearance on 12 October 2004, Ljubiša Beara appeared before Judge Bonomy for his further appearance. The Defence was not ready to enter a plea. On 11 November 2004, a new further appearance was held. The Accused pleaded not guilty to the charges of the Indictment.

KVOČKA *et al.* Case (“Omarska, Keraterm and Trnopolje Camps”)

Pre-Appeal Judge Weinberg de Roca

On 10 November 2004, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence.

ORDER APPOINTING A TRIAL CHAMBER FOR THE PURPOSE OF DETERMINING WHETHER AN INDICTMENT SHOULD BE REFERRED TO ANOTHER COURT UNDER RULE 11 *BIS*
