Following his transfer to the Tribunal on 3 December 2004, Dragomir Milošević appeared before Judge Orie for his initial appearance on 7 December 2004. He pleaded not guilty to all the counts of the Indictment.

Appeals Chamber - Judges Meron (Presiding), Pocar, Mumba, Güney and Weinberg de Roca DECISION ON PROSECUTION'S APPEAL AGAINST DECISION GRANTING PROVISIONAL RELEASE

On 3 December 2004, the Appeals Chamber dismissed the Prosecution Appeals against Stanišić's and Simatović's provisional release in two separate Decisions. The Appeals Chamber was not satisfied that the Prosecution had established that the Trial Chamber erred in finding that both accused be provisionally released (see *Press Release* No. 923).

On 9 December 2004, the Appeals Chamber changed the schedule and ordered that the public hearing to deliver the judgement in appeal be held on 17 December 2004 at 12.30 p.m. in Courtroom I.

DECISION ON ASSIGNED COUNSEL'S MOTION FOR WITHDRAWAL

On 7 December 2004, the Trial Chamber determined that the application by court assigned counsel, Mr. Steven Kay and co-counsel Ms. Gillian Higgins, to withdraw from their assignment should be denied. The Trial Chamber instructed the Registrar to deny the application pursuant to his powers under Article 19 of the Directive On Assignment of Defence Counsel (see *Press Release* No. 924).
