**DECISION ON PROSECUTION MOTION TO AMEND THE INDICTMENT**

On 24 March 2005, the Pre-Trial Judge granted the Prosecution request to amend the indictment with the exception as set out in the Decision and he directed the Prosecution to file the amended indictment within seven days of the date of the Decision. A further initial appearance to enable the Accused to enter a plea on the two new charges will be held on 5 April at 4 p.m.

**KVOČKA Case**

*President of the Tribunal - Judge Meron*

On 30 March 2005, the President of the Tribunal, granted Miroslav Kvočka’s Request for early release pursuant to Article 28 of the Statute of the Tribunal, and Rules 124 and 125 of the Rules of Evidence and Procedure (see *Press Release* No. 955).
