**CONTEMPT PROCEEDINGS AGAINST KOSTA BULATOVIĆ  
DECISION ON CONTEMPT OF THE TRIBUNAL**

On 13 May 2005, the Trial Chamber found that Kosta Bulatović’s conduct constituted serious contempt of the Tribunal and it sentenced him to four months imprisonment. The Trial Chamber suspended the operation of that sentence for a period of two years. The sentence shall not take effect unless during that period Kosta Bulatović commits another offence anywhere that is punishable with imprisonment, including contempt of court. Judge Bonomy appended a Separate Opinion to the Decision (see *Press Release* No. 970).
