On 3 November 2005, the Parties appeared before the Pre-Trial Judge for a further initial appearance of the accused pursuant to Rule 50(B) of the Rules of procedure and evidence. The accused did not enter a plea in relation to new charges in the modified amended indictment filed on 15 July 2005. Subsequently, the Pre-Trial Judge, pursuant to Rule 62(A) of the Rules, entered a plea of "not guilty" on the accused's behalf.

DECISION ON INTERLOCUTORY APPEAL FROM TRIAL CHAMBER DECISION DENYING VUJADIN POPOVIĆ'S APPLICATION FOR PROVISIONAL RELEASE

On 28 October 2005, the Appeals Chamber denied the Defence's appeal on the decision on provisional relase of Vujadin Popović filed on 22 August 2005. Vujadin Popović was denied provisional release on 22 July 2005.

EXTENSION OF ORDER RELATING TO PROSECUTION MOTION TO STAY THE TRIAL CHAMBER'S DECISION OF 12 OCTOBER 2005 REGARDING CONDITIONS OF PROVISIONAL RELEASE OF RAMUSH HARADINAJ

On 31 October 2005, pursuant to Rule 54 of the Rules, Trial Chamber II ordered that the stay of the Trial Chamber's decision on defence motion of Ramush Haradinaj to request re-assessment of conditions of provisional release granted 6 June 2005, which is currently in place, be extended until 21 November 2005, or until such date as the Appeals Chamber may render its decision, if this would occur prior to this date. The Trial Chamber decided to remain seized of the matter.

ORDER ON THE CONSOLIDATED AMENDED INDICTMENT

On 31 October 2005, pursuant to Article 19.1 of the Statute of the Tribunal and Rules 50(A)(i)(c), 50(A)(ii) and 50(C) of the Rules, Trial Chamber II granted the Prosecution leave to file the consolidated amended indictment under a single case number IT-05-88-PT filed on 28 June 2005 and ordered that:

- a) the proposed consolidated amended indictment filed by the Prosecution on 28 June 2005 be the operative indictment in the case of Prosecutor v. Popović, Beara, Nikolić, Borovčanin, Tolimir, Miletić, Gvero, Pandurević and Trbić, case no. IT-05-88-PT, with the caveat that:
- b) the accused Popović, Beara, Nikolić, Borovčanin, Tolimir, Miletić, Gvero, Pandurević and Trbić shall have 30 days as of the date of filing of the present order in which to file any preliminary motion against the form of the consolidated amended indictment pursuant to Rule 72 of the Rules; and that
- c) the Popović motion on the form of the indictment, Miletić motion on the form of the indictment and Pandurević motion on the form of the indictment are moot.
