## HALILOVIĆ Case

Trial Chamber I – Judges Liu (Presiding), El Mahdi and Mumba

On 16 November 2005, Trial Chamber I rendered the judgement in the case of the Prosecutor v.Sefer Halilović. Sefer Halilović was found not guilty and therefore acquitted of Murder, a Violation of the Laws or Customs of War as charged in the indictment – See Press Release number 1021 dated 16 November 2005.
