DECISION ON PROSECUTION'S MOTION FOR VARIANCE OF PROTECTIVE MEASURES IN THE PROSECUTOR v. MARIJAČIĆ & REBIĆ CASE

On 16 January 2006, pursuant to Rule 75(G) and (I) of the Rules, the Appeals Chamber granted in part the Prosecution's request, filed confidentially and *ex parte* on 1 November 2005, that the protective measures granted with respect to witness Johannes van Kuijk's identity and statement be lifted. The Appeals Chamber's order states that:

- all protective measures granted with respect to witness van Kuijk in the hearing of 16 December 1997 be lifted:
- the fact that witness van Kuijk testified, his statements to the Prosecution, as well as his testimony transcripts in this case, may be referred to publicly and in open session.

DECISION ON PARTLY CONFIDENTIAL DEFENCE MOTION REGARDING THE CONSEQUENCES OF A PARTY FAILING TO PUT ITS CASE TO WITNESSES PURSUANT TO RULE 90(H)(ii)
