RAŠEVIĆ & TODOVIĆ Case

Judge Antonetti

On 21 February 2006, the Parties appeared before Judge Antonetti for a Status Conference pursuant to Rule 65*bis* of the Rules. The accused Rašević was present while S. Todović was absent due to his illhealth.

MILAN LUKIĆ Case

Judge Bonomy

On 24 February 2006, pursuant to Rule 62 of the Rules, the parties appeared before Judge Bonomy for the initial appearance of Milan Lukić. The accused pleaded not guilty to all counts of the indictment.

DECISION ON PROSECUTION MOTION FOR THE ADMISSION INTO EVIDENCE OF UNPROFOR SPANISH BATTALION DOCUMENTS

On 17 February 2006, pursuant to Rules 54 and 89(C) of the Rules, Trial Chamber II denied the Prosecution's request to admit into evidence 304 documents originating from United Nations Protection Force (UNPROFOR) in Bosnia and Herzegovina, filed on 8 February 2006.

RAŠEVIĆ & TODOVIĆ Case

Appeals Chamber – Judges Pocar (Presiding), Güney, Daqun, Vaz and Schomburg

DECISION ON RULE 11 bis REFERRAL

On 23 February 2006, the Appeals Chamber quashed the decision by the Referral Bench, dated 8 July 2005, to refer Rašević & Todović case to Bosnia and Herzegovina. The decision further stated that:

- the matter is remitted to the Referral Bench for further consideration consistent with this decision;
- the Referral Bench is directed to defer issuance of any further decision on referral of this case pursuant to Rule 11*bis* of the Rules until the Trial Chamber renders a decision on the motion on the form of the joint amended indictment; and
- the execution of the decision dated 8 July 2005 is suspended with respect to the accused Mitar Rašević until a decision on the motion on the form of the joint amended indictment has been rendered and a decision confirming the operative indictment is issued.

SLOBODAN MILOŠEVIĆ Case

Trial Chamber III – Judges Robinson (Presiding), Kwon and Bonomy

DECISION ON ASSIGNED COUNSEL REQUEST FOR PROVISIONAL RELEASE

On 23 February 2006, pursuant to Rules 54, 65, 126*bis* and 127 of the Rules, Trial Chamber II denied the request by the assigned counsel that the accused be granted provisional release for the purpose of medical treatment in a medical institution in Moscow, filed on 20 December 2005.
