DECISION ON PROSECUTION'S CONSOLIDATED MOTION TO AMEND THE INDICTMENT AND FOR JOINDER

On 14 July 2006, pursuant to Rules 48, 50 and 54 of the Rules, Trial Chamber II ordered that the case of *Prosecutor v. Ante Gotovina* (case number IT-01-45) and the case of *Prosecutor v. Ivan Čermak and Mladen Markač* (case number IT-03-73) be joined and instructed the Registrar to assign a common case number.

On 17 July 2006, the Registrar of the ICTY decided that the case *Prosecutor v. Ante Gotovina, Ivan Čermak and Mladen Markač* be assigned the new case number IT-06-90.
