DECISION ON ŠEŠELJ'S REQUEST THAT THE ICTY PRESIDENT ORDER THE REMOVAL OF ALL OBSTACLES THAT RESTRICT THE EQUALITY OF ALL RADIO AND TELEVISION STATIONS TO BROADCAST ŠEŠELJ'S TRIAL

On 11 September 2006, Judge Pocar dismissed as being without merit the accused's request asking for an order to remove all obstacles that restrict the equality of all radio and television stations in Serbia with respect to the right to television and radio broadcasts from the ICTY courtrooms, filed on 14 July 2006.
