ORDER REGARDING OPENING STATEMENTS

On 25 September 2006, pursuant to Rules 84 and 84*bis* of the Rules, Trial Chamber I ordered, *inter alia*, that the accused shall be allowed, if he so wishes, to make a statement at the trial session on 2 November 2006. The Chamber made the order by majority and Judge Moloto dissented in part.

MARIJAČIĆ & REBIĆ Case

JUDGEMENT

On 27 September 2006, the Appeals Chamber dismissed all the grounds of appeal filed by the appellants Marijačić and Rebić and affirmed the imposition of a fine of 15,000 euro on each of the appellants – *See Press Release number 1116, dated 27 September 2006.*
