DECISION ON USE OF TIME

On 9 October 2006, pursuant to Articles 20 and 21 of the Statute and Rules 54 and 90 (F) of the Rules, the Trial Chamber ordered, *inter alia*, that:

- the Prosecution shall have 220 hours in total for the presentation of the remainder of its case, which shall be counted from 9 October 2006;
- for *viva voce* witnesses, the Defence shall have collectively the same amount of time as the Prosecution has taken for the cross-examination of a witness.
