Vojislav ŠEŠELJ Case

Appeals Chamber - Judges Pocar (Presiding), Shahabuddeen, Güney, Vaz and Meron

DECISION ON APPEAL AGAINST THE TRIAL CHAMBER'S DECISION ON ASSIGNMENT OF COUNSEL

On 20 October 2006, the Appeals Chamber reversed the Trial Chamber's decision to assign counsel to Vojislav Šešelj – *See Press Release number 1123, dated 20 October 2006.*

ORDER CONCERNING APPOINTMENT OF STANDBY COUNSEL AND DELAYED COMMENCEMENT OF TRIAL

On 25 October 2006, Trial Chamber I (Judges Orie, Robinson and Höpfel) ordered, *inter alia*, that the commencement of the trial be postponed until further order and that a Status Conference be held on 1 November 2006.

DECISION ON MOTION TO AMEND THE INDICTMENT AND ON CHALLENGES TO THE FORM OF THE AMENDED INDICTMENT

On 25 October 2006, pursuant to Article 19 of the Statute and Rules 50, 54 and 72 of the Rules, the Trial Chamber ordered, *inter alia*, that the Prosecution is granted leave to make all amendments as proposed in the amended indictment, filed on 26 April 2006, which shall be the operative one in this case – *See Press Release number 1125 dated 26 October 2006*.

DECISION ON INTERLOCUTORY APPEALS AGAINST THE TRIAL CHAMBER'S DECISION TO AMEND THE INDICTMENT AND FOR JOINDER

On 25 October 2006, the Appeals Chamber confirmed the Trial Chamber's decision of 14 July 2006 to join two cases involving Ante Gotovina, Ivan Čermak and Mladen Markač in one indictment and accepted the proposed amendments to the indictment – See Press Release number 1124 dated 26 October 2006.
