DECISION ON JOINT DEFENCE MOTION FOR PROVISIONAL RELEASE DURING WINTER RECESS

On 5 December 2006, pursuant to Articles 20 and 21 of the Statute and Rules 54 and 65 of the Rules, the Trial Chamber denied the "Joint motion for provisional release during the winter recess".

On 6 December 2006, the six accused filed a joint appeal against the Decision by the Trial Chamber.

URGENT ORDER TO THE DUTCH AUTHORITIES REGARDING HEALTH AND WELFARE OF THE ACCUSED

On 6 December 2006, pursuant to Article 29 of the Statute and Rule 54 of the Rules, the Trial Chamber ordered the authorities of the Kingdom of the Netherlands, *inter alia*, to provide medical services under the Agreement – which may, in the case of medical necessity, include intervention such as drip-feeding – with the aim of protecting the health and welfare of the accused and avoiding loss of life, to the extent that such services are not contrary to compelling internationally accepted standards of medical ethics or binding rules of international law.

DECISION ON DEFENCE MOTIONS FOR PROVISIONAL RELEASE OF RADIVOJE MILETIĆ AND MILAN GVERO
