On 7 February 2007, Trial Chamber I rendered its judgement: Domagoj Margetić was sentenced to three months' imprisonment and a fine of 10,000 euros – See Press Release, number 1145, dated 7 February 2006.

## DECISION ON PROSECUTION APPEAL CONCERNING THE TRIAL CHAMBER'S RULING REDUCING TIME FOR THE PROSECUTION CASE

On 6 February 2007, the Appeals Chamber ordered that the decision reducing the number of hours for the Prosecution case be remanded to the Trial Chamber for its renewed assessment and consideration of whether the reduction of time would allow the Prosecution a fair opportunity to present its case in light of the complexity and number of issues that remain.
