## ORDER OF PROVISIONAL RELEASE FOR MLADEN MARKAČ

On 9 February 2007, pursuant to Rule 54 of the Rules, the Trial Chamber ordered that the accused Markač be provisionally released as of 10 February 2007.

#### DECISION TO REINSTATE THE PROVISIONAL RELEASE OF IVAN ČERMAK

On 15 February 2007, pursuant Article 29 of the Statute and Rules 54 and 65 of the Rules, the Trial Chamber ordered that the provisional release of Ivan Čermak be reinstated as of 16 February. The release was granted under the same conditions as last time but with a number of new clarifications specified in the decision.
