ORDER ON CLOSE OF PROSECUTION CASE-IN-CHIEF, RULE*bis* PROCEEDINGS, AND DEFENCE RULE 65*ter* FILINGS

On 5 March 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54, 65ter, 85(C), 94*bis* and 98*bis* of the Rules, the Trial Chamber ordered, *inter alia*, that:

- the Prosecution case shall close its case-in-chief on or before 23 March 2007;
- during the week of 26 March 2007, the Chamber shall hear oral submission pursuant to Rule 98bis;

ORDER TO VACATE WARRANT OF ARREST AND ORDER IN LIEU OF INDICTMENT

On 9 March 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54, 55, 56, 57, 58, 59, 59*bis* and 77 of the Rules, the Trial Chamber vacated the warrant of arrest, order for surrender of Božidar Protić and order in lieu of indictment on contempt concerning Božidar Protić, issued on 22 February 2007 following his initial refusal to appear as a witness in this case.

DECISION ON SIXTH REQUEST FOR ALTERATION OF CONDITIONS OF PROVISIONAL RELEASE

On 6 March 2007, pursuant to Rules 54 and 65 of the Rules, the Trial Chamber granted a motion by the accused and ordered that he is permitted to visit his family in the place of Koštunići in Serbia on 15-30 March, 15-30 April and 15-30 May 2007.

DECISION ON FINDING OF MISCONDUCT OF ATTORNEY MIROSLAV ŠEPAROVIĆ

On 6 March 2007, pursuant to Articles 20 and 21 of the Statute, Rule 46(A) of the Rules and Articles 9, 14, 26 and 38 of the Code, the Trial Chamber affirmed its finding in the decision on conflict of interest and determined that Miroslav Šeparović is no longer eligible to represent Mladen Markač in this case before the Tribunal and ordered the accused to immediately engage new counsel to represent him. The Trial Chamber ordered new counsel to inform them as soon as practical, and no later than 30 March 2007, on how much time he or she needs to fully take over the case.

DECISION ON PROSECUTION'S URGENT MOTION TO REVOKE UNMIK'S DELEGATED AUTHORITY TO MONITOR RAMUSH HARADINAJ'S POLITICAL ACTIVITIES

On 7 March 2007, Trial Chamber I denied the Prosecution's motion requesting that the UNMIK's delegated authority to monitor and decide upon Ramush Haradinaj's political activities be revoked.
