Haradinaj et al. trial. The indictment was confirmed on 5 November 2007 – *See Press Release, number 1196, dated 9 November 2007.*

However, Avni Krasniqi decided to testify on 14 and 15 November and subsequently the Trial Chamber granted the Prosecution motion to withdraw the indictment against him and ordered his release.

Sadri SELCA Case (“contempt”)

ORDER ON THE LIFTING OF CONFIDENTIALITY

On 13 November 2007, Trial Chamber I directed the Registrar to make public the indictment against Sadri Selca, charged with contempt of court by failing to comply with an order to appear as a witness in the Haradinaj et al. trial. The indictment was confirmed on 7 November 2007 – *See Press Release, number 1197, dated 13 November 2007.*

However, Sadri Selca decided to testify on 15 November and subsequently the Trial Chamber granted the Prosecution motion to withdraw the indictment against him and ordered his release.

Vojislav ŠEŠELJ Case

ORDONNANCE RELATIVE AU TEMPS ALLOUÉ À L’ACCUSATION EN VERTU DE L’ARTICLE 73bis DU REGLEMENT DE PROCÉDURE ET DE PREUVE (ORDER ON TIME ALLOCATED TO THE PROSECUTION PURSUANT TO RULE 73bis OF THE RULES OF PROCEDURE AND EVIDENCE)

On 13 November 2007, pursuant to Article 21 of the Statute and Rules 54 and 73bis of the Rules, Trial Chamber III ordered that the Prosecution shall have 120 hours for presenting evidence, covering only examination-in-chief. The accused shall have the same time-limit for the cross-examination of the Prosecution witnesses during the presentation of his case.

DECISION ON MOTION TO AMEND THE INDICTMENT

On 14 November 2007, pursuant to Rule 50 of the Rules, Trial Chamber II denied a motion by the Prosecution to amend the current indictment.

Therefore, the second amended indictment is still the operative indictment in this case.

On 14 November 2007, the Appeals Chamber ordered that the appeal hearing shall be held on 4 December and 5 December 2007 in courtroom I.

ORDER RECALLING ENVER HADŽIHASANOVIĆ FROM PROVISIONAL RELEASE

On 14 November 2007, pursuant to Rule 65 of the Rules, the Appeals Chamber ordered Enver Hadžihasanović to return to the UN Detention Unit in The Hague for the duration of the appeal hearing in his case.
