#### DECISION ON MOTIONS FOR PROVISIONAL RELEASE DURING THE WINTER JUDICIAL RECESS

On 7 December 2007, pursuant to Article 29 of the Statute and Rule 65 of the Rules, Trial Chamber II granted the Defence motions and ordered that Radivoje Miletić and Milan Gvero be provisionally released during the winter recess. The order specified that Radivoje Miletić be released on or after 15 December 2007 until no later than 7 January 2008 whereas Milan Gvero shall be released on or after 16 December 2007 until no later than 8 January 2008.
